DESTINATION THAILAND VISA "DTV"

(Workcation, Soft Power related activities, spouse/children under 20 years old)

Multiple Entry | 5 Year

Application for DTV requires approval from the Royal Thai Embassy prior to making visa fee payment

This type of visa will issue to the applicant who wishes to enter the Kingdom of Thailand with the following purposes:

- 1. To enjoy workcation
- 2. To participate in following activities: Muay Thai courses, Thai cooking classes, sport training, serious and continuous medical treatment, seminars, and music festival.
- 3. Spouse and dependent children (age under 20 years old) of DTV holder.

DTV visa allows holder to stay in Thailand for 180 days per entry. Holder may extend the period of stay for 1 time per each entry, for a period not exceeding 180 days (maximum stay will be 180 days + 180 days per entry). Holder may reenter Thailand as often as required for as long as the visa remains valid.
